2.2 Review of Status Report

Review of actions and progress arising from previous meetings and decisions. Points raised as follows:

<u>Climate Change Initiatives</u> – on hold. WALGA is seeking funding for Regional Climate Alliances in the 2025 State budget.

<u>Corella Management</u> – Next steering group meeting is on 4 December via Teams. Second quarterly report has been distributed for feedback.

<u>Housing shortage</u> – Waiting on advice of outcomes for the State IDF (stream 3) on and the Federal Housing Support Program (stream 2) application.

Regional collaboration on waste – EO to follow-up with RDA mid-west Gascoyne regarding a project with four local governments develop a regional waste strategy.

<u>Live sheep export ban</u> – Letter sent to the Hon Julie Collins MP, Minister for Agriculture, Fisheries and Forestry, and copied to Darren West (Agricultural region/Labor), Shane Love (Moore/Nationals) and Mia Davies (Bullwinkle/Nationals). Response received from Shane Love. SF – At a recent election briefing the federal coalition identified overturning the ban on live sheep export as one of their top 8 priorities.

<u>Branding & Promotion</u> - Brief was distributed to seven providers (including 3 from WALGA's preferred supplier) directly. Three proposals were received by the closing date of 15 November.

3.1.2 Regional Development Australia - Wheatbelt

Josh Pomykala, Director Regional Development (online)

- RDA is drafting a new strategic plan, first time in 5 years, outline federal charter responsibilities.
- Will be offering an economic development training course for LG officers and elected members to be delivered by subregions in 2025.
- Recent release of Wheatbelt LG economic data provided by sub region and LG.
- Advocating for better resourcing of education and more support for regional educators.
- Providing support for LG projects seeking funding.

- Defence manufacturing industry project is progressing with the Wheatbelt Business Network.
- Will be in Toodyay mid-December, happy to meet face to face.

3.1.3 Wheatbelt Development Commission

Presentation by Renee Manning, A/CEO, Wheatbelt Development Commission.

Regional Housing

- WDC is working with 16 LGAs to undertake sub regional housing demand and options assessments. An additional 10 LGA are seeking to undertake similar assessments.
- 6 Shires were successful (\$900K) in Stream 1 of the Commonwealth Governments Housing Support Program.
- 10 Shire have applied for Stream 2 of the Housing Support Program.
 Seeking \$32M with 60% LGA co-contribution to activate 200 lots with an initial development of 182 houses and full development of 400.
- 8 Shires have applied for Round 3 of the State Governments Infrastructure Development Fund.

Tourism

- Tourism WA has released the Wheatbelt Tourism Strategy building upon the Destination Perth, Golden Outback and Australia's Coral Coast Destination Management Plans – link here https://assets.australiasgoldenoutback.com/images/WHEATBELT-RTDS.pdf
- Regional Development Portfolio actively engaged in the Tourism development opportunities and advocating for key Wheatbelt priorities.

Telecommunications

- \$2.9M for the establishment of 80 Automatic Transfer Units across the Wheatbelt and Goldfields.
- WDC, LGAs and ROCs have been advocating for these. Enable third parties to connect generators to towers and exchange sites.
- Locations will be determined based upon historical outages (including 2024 supercell storm event) and strategic upstream and downstream connection points.
- The program is a pilot.
- Generators will be stored in key regional centres to enable ease of deployment if required.
- WDC continuing to work on the network hardening and resilience programs (22 Wheatbelt locations secure additional battery backup capacity earlier this year).

 Working with Telstra on opportunities for the intercity fibre program including getting some offtake points near Northam for fright and logistics and data centre development.

Regional Drought Resilience Plan

- Wheatbelt RDRP in development, consultation near completion.
 Funded by Future Drought Fund and RforR.
- Plan will be high-level, though aims to identify key projects/actions to progress drought and climate resilience in the region.

Industrial land, Freight and Logistics

- Working with the private sector and the Shire of Northam on a number of key freight and logistics projects and the repositioning of Northam as a key intermodal transport Hub.
- Continued priority if the expansion of the Avon Industrial Park including road and rail investment and State 3 expansion.

RED Round 7

- · Announced in October
- \$1.16M across 10 projects.
- Program was highly competitive.

Renewable energy

- Continuing to work with LGAs, proponents and PoweringWA on capturing regional opportunities and managing impacts from the energy transition.
- Regional forums held in Moora and Darkan and a session at the Central Country Zone (Wandering).
- WDC focus is on ensuring community benefit frameworks/outcomes are suitable and Skills and Workforce development (noting \$70M commitment to WA clean energy skills centre of excellence), Local procurement and housing.
- Wheatbelt currently produces ~1000MW, with ~8000MW in planning can't decarbonise the SWIS without the Wheatbelt.

Living Well in the Wheatbelt

- Wheatbelt District Leadership Group is finalising a 10 year Strategy.
- First region in WA to develop one.
- Focus on Starting Well, Growing Well, Living and Working Well, and Aging Well.
- The DLG includes the senior leads of all health and wellbeing agencies, representatives from the 3 WALGA zones and the CEO of the 3 Noongar Corporations, CEO WDC.

Local Government Investment preparedness

• \$18B pipeline of private sector investment

- CL Regarding end of life considerations and decommissioning for renewable energy infrastructure, who is responsible?
- RM No real answer, supposed to be identified as part of the development application process, however the question needs to be asked.
- KM Can WDC be a partner is planning for regional waste services?
- RM Contact Chris Sharples (WDC); WEROC and NEWROC regarding collaborative waste planning.

3.2 Matters referred by the Officer's Group for consideration or decision;

3.2.1 Bullwinkle Electorate Discussion

Members to identify common ground and refine issues to address at a meeting to be arranged with candidates of the Bullwinkle electorate and AROC members.

What issues do we have in common?

- Federal Assistance Grants
- Regional Waste Servicing & Infrastructure (State)
- Housing
- Road native vegetation clearing permits (State)

What is our combined approach? I.e. collaboration from a regional perspective on three key issues affecting electorate LGs (and AROC members and/or other Wheatbelt LGs).

- CL Attended WALGA election workshop, asked staff if there is value in speaking to candidates? Who is behind the candidate, the real people we need to influence?
- SF Suggested reaching out to GRA partners, lobbying experts to seek advice on how to approach.
- AB may have missed the boat with advocacy as were asked to provide a list of priorities some time ago.
- PB can you write to the candidates instead of meet with them?
- SF March election date is most likely.
- AB AROC is small fry (low population) compared to other LGs in the Bullwinkle electorate, need to demonstrate commonality to have an impact.
- CL Suggested AROC write to candidates outlining AROC priorities, ask them to outline their position on those issues, and request to meet to discuss actions required.

- 3.3 Matters raised by individual member local governments for consideration:
- 3.3.1 Interest from Shire of Wongan to join AROC

Mr Sam Dolzadelli, CEO, for the Shire of Wongan-Ballidu has expressed interest in the Shire becoming a member of AROC. The Shire of Wongan-Ballidu is not currently a member of a ROC.

The AROC MOU allows for the Governance Group to allow or invite new members to join provided the Governance Group is in unanimous agreement. Any new member will be required to buy in to AROC, the buy in figure is to be determined by preparing a balance sheet for AROC and dividing the net equity position by the number of members.

RECOMMENDATION

That AROC members consider the probable advantages and/or any disadvantages of accepting an additional member to AROC, and determine whether to formally invite the Shire of Wongan-Ballidu to join AROC.

Discussion

- SF Summarised preliminary discussion with Sam Dolzadelli, CEO, Shire of Wongan, regarding the possibility of joining AROC.
- AB Asked if the Shire of Wongan was currently a member of another ROC? SF No.
- CA Cunderdin has expressed interest in joining too.
- AB Should we consider reviewing AROC membership before determining to invite Wongan to join?
- CL AROC's advantage is in neighbouring the metro area (an arc), strategic move would be to add Chittering and Beverley, which border metro arc. More in common than further eastern LGs.

- Formation of Bullwinkle electorate provides opportunity to review and be more strategic.
- CA Suggested that AROC reviews its strategic plan to determine the advantages and disadvantages of expanding its memberships.
- CL Suggested AROC undertake a SWOT analysis of membership to determine strategic members for AROC.
- KM Question to Renee Manning would WDC facilitate discussions with other Wheatbelt LGs not currently linked into a ROC, to determine the most strategic regional alignment of LGs?
- RM Defining commonality helps to determine ROC memberships e.g. WEROC members have the Great Eastern Highway freight route as a common factor; agreed with the value in considering strategic memberships to strengthen ROCs.
- AB Suggested that AROC review its strategic plan to determine the advantages and disadvantages of expanding its memberships.







CASE STUDY

AvonWest Logistics Hub

- Procon is developing a 62ha freight and logistics hub in Northam. The Estate is forecast to house large multinational package and parcel operators providing east/west road freight operators with storage and final mile delivery both in and out of Greater Perth.
- Connectivity to the InterCity Fibre network will open up opportunities for robotics and data centres infrastructure investment.



CASE STUDY

Renewable Energy

- The Wheatbelt is critical to States renewable energy and decarbonization agenda. The regions renewable energy output expected to increase 1GW to 8GW over the next 10-15 years
- Renewable energy projects are likely to yield high CAPEX but low
- · WDC is working with Local Government, renewable energy providers, Western Power and PoweringWA to secure long term positive outcomes for the region and its communities.

CASE STUDY

Regional Housing

- · The Wheatbelt is experiencing an acute housing shortage for over a 1000 workers in the next 10 years, resulting in an economic opportunity cost of up to \$265,000 for every worker that is not able to be accommodated
- *WDC is working with the regions Local Government Authorities to support the activation of regional land assets and facilitate public and private investment into regional housing solutions.



Telecommunications

- · 80 Automatic Transfer Units to be rolled out across the Wheatbelt and Goldfields regions
- Improved digital communications (network hardening and coverage expansion) are a key priority for the Wheatbelt region
- 22 Wheatbelt projects announced under Round 2 of the Mobile Network Hardening Program (MNHP) and 7 Wheatbelt projects currently underway through the Regional Connectivity Program (RCP) and Mobile Black Spot Program (MBSP)

- · Support Aboriginal economic opportunities arising from the SW Native Title Settlement as a significant economic development package
- Support Aboriginal economic participation and unlock barriers for opportunities to grow participation

South West Native Title Settlement

- . The WDC is committed to working with the Ballardong, Yued, and Gnarla Kaarla Boodja Aboriginal corporations to foster economic development opportunities
- The WDC represents the Regional Development Commissions on the Noongar Economic Participation Framework (NEPF) Steering Committee. The NEPF seeks optimize opportunities arising from the Settlement and to grow the Noongar business capability and capacity, and participation in the economy



Aboriginal Business procurement

- WDC is committed to working with the Noongar Chamber of Commerce and Industry (NCCI) to build business capacity and capability through the regional implementation of the State Aboriginal Procurement Policy (APP), Buy Local Policy (BLP) and private sector partnerships
- The WDC is working NCCI and MainRoadsWA to identify opportunities maximise contracting, training and employment opportunities in regional road programs.



CASE STUDY

Living Well in the Wheatbelt

- The Wheatbelt District Leadership Group (DLG) is developing a Living Well in the Wheatbelt Plan: Towards 2035 and Beyond to guide investment and projects across the health and human services sectors
- The DLG seeks to ensure that we support the most vulnerable in our community and regardless of someone's circumstance they have the ability to start well, grow well, live and work well, and age well in the Wheatbelt.



CASE STUDY

Building Wheatbelt preparedness

- The WDC is working with the private sector to facilitate the delivery of a \$15 billion pipeline of regional projects across the agriculture, mining, renewable energy, decarbonization and freight and logistics sectors.
- Communities that have experienced limited growth in the past are often unprepared for Incoming investment.
- WDC is working with local governments aggregations to develop approaches to planning for economic growth.



Opportunities for Avon

Harness the potential of tourism growth

- The Avon Valley is part of the Destination Perth Regional Tourism Organisation, highlighting its popularity as a day trip and overnight destination.
- With the release of Tourism WA's Wheatbelt Regional Tourism Strategy, businesses should seize the new opportunities for regional tourism growth.

Maximise benefits from mining sector expansion

- Mining contributes \$4.28 billion to the Wheatbelt economy, nearing agriculture's \$4.32 billion, and may become the leading industry sector in coming years.
- The Avon sub-region hosts high-grade "green metal" deposits, with Chalice Mining's Gonneville project offering significant opportunities.

Enhance freight and logistics connectivity

- A WDC report estimates \$4.7 billion in freight passed through Northam between 2018 and 2022, with \$270 million in private investment planned for local infrastructure.
- Procon Development's AvonWest Logistics Hub at the Northam Road Train Assembly Area (RTAA) could unlock \$250 million in total investment, generating 686 jobs.

Unlock opportunities through industrial land development

 Demand for affordable, serviced industrial land is rising across the Avon and Wheatbelt regions. All Stage 1 and 2 lots at Northam's Avon Industrial Park are sold, with new lots expected within 12 months.
