PURPOSE OF THE REPORT

To authorise expenditure of more than \$5,000 for provision of legal advice relating to the *Aboriginal Heritage Act 1972* in accordance with Council's Compliance and Enforcement Policy.

BACKGROUND

Following receipt of a complaint and subsequent investigation, the Department of Planning, Lands and Heritage has issued two prosecution notices in relation to alleged breaches of the *Aboriginal Heritage Act 1972*. The first hearing for these matters is at 10.00am on 26 February 2024 at Northam Courthouse. Officers have been advised to seek legal advice and possible representation to defend the matter.

COMMENTS AND DETAILS

Council's Compliance and Enforcement policy restricts the authority of the CEO to a maximum of \$5,000 for legal representation. Preliminary advice will not exceed this threshold. However, if legal representation is required to defend the Shire's position, indications are that costs could exceed \$15,000. Therefore, Council approval is required to authorise expenditure above \$5,000 should the need arise.

Officers have also contacted the Shire's insurers who are reviewing the matter with a view to a possible claim on the Shire's liability insurance to support the defence and any fines issued.
