

## PROPOSED APPLICATIONS FOR PUBLIC COMMENT RENEWAL OF EXTRACTIVE INDUSTRIES – CLAY

The Shire of Toodyay has received an application from AUSTRAL BRICKS (WA) PTY LTD to renew an extractive industry licence at Lot 11 Chitty Road in Hoddy's Well.

The applicant is seeking approval to renew the existing extractive industry licence to remove clay for construction purposes from an area on the property of approximately 2.84 hectares. It is expected that an average of 70,000 tonnes of clay is to be excavated per year. The anticipated duration of the extraction program is approximately 10 years. Submissions for this proposed development close:

**4.00pm Friday, 21 September 2018.**

The Shire of Toodyay has received an application from MIDLAND BRICK to renew a clay extractive industry licence at Lot 3 Morangup Road in Morangup.

The applicant is seeking approval to remove clay for construction purposes from an area on the property of approximately 17.9 hectares. This includes the current pit, an area undergoing rehabilitation and three new stages. It is expected that up to 30,000 – 50,000 tonnes of clay is to be excavated per year. The anticipated duration of the extraction program is approximately 10 years.

If you haven't already received your rates, it won't be long. Rates Notices were posted out last Friday (7 September 2018). **Instalment Option:** If you choose to pay your rates by instalments, a fee of \$22.50 and interest of 3% pa will be charged and incorporated into the payment schedule.

**Alternative Payment Arrangements:** If you are unable to pay your rates due to financial hardship, you can apply for a Payment Arrangement. The Administration Fee is \$70.00 and interest will accrue on all outstanding balances at 7.5% per annum until the account is settled in full. The Payment Arrangement must be settled within the current financial year.

**Pensioner and Senior Concessions:** If you are a Pensioner or Senior card holder, you may be eligible to apply for a rebate for your Rates, Emergency Services Levy and annual Water Corporation Rates. Please note that rubbish charges and waste transfer station fees are not subject to a concession. To be eligible for a concession, an applicant must be: the owner and reside at the property on July 1 of the rates year; in receipt of a pension or hold a Pensioner Concession Card; a State Concession Card; in receipt of a Seniors Card or in receipt of a Seniors Card and Commonwealth Seniors Health Card.

Eligible Pensioners are entitled to claim a rebate of 50% of the current year's rates, up to a maximum of \$750 or may apply to defer those rates. Seniors who meet the eligibility criteria are entitled to claim a rebate of 25% of the current year's rates, up to a maximum of \$288.70.

Concessions apply after the eligible ratepayers have registered their entitlement with either the Shire or the Water Corporation. Pro-rata rebates may be offered. You must first notify the Shire or the Water Corporation if your circumstances change in relation to your pension, ownership of the property or whether you continue to occupy the property.

Please note that the Pension and Senior Concession is provided by the Department of Finance however, as part of the 2018/19 Budget, Council has resolved to provide an additional \$25.00 concession to **PENSIONER Concession holders ONLY**.

## Bridge Closure a BAD Decision

The decision by the Public Transport Authority (PTA) to close the railway footbridge in Toodyay is poor public policy and an abdication of responsibility by the State Government. Toodyay is split in two by the standard gauge railway which carries all rail freight between Perth and eastern Australia. Toodyay's elderly and disabled residents are being asked to take their chances with an uncontrolled level crossing between these behemoths.

The PTA claims that under the Public Works Act the bridge should always have been the responsibility of the Shire of Toodyay. It would have been had it ever been handed over. It wasn't. In that other great policy disaster involving the leasing of the public rail network there was an agreement between Brookfield and the PTA that the PTA would continue to maintain the bridge. Somehow that agreement was forgotten.

What we have now is a bridge under the control of the PTA that has been neglected for 50 years until it is in such a state that they have decided to demolish it. They are however prepared to gift it to the Shire of Toodyay so long as the Shire foots the repair bill.

The Shire has been here before. The State Government handed the Shire the footbridge across the Avon River which connects the town with the high school. After accepting the gift it cost the Shire almost \$1 million to repair it and make it safe. This was almost 10 years ago but the Shire has learnt that lesson.

This railway footbridge is an essential piece of infrastructure for the people of Toodyay. The Shire has told the PTA on several occasions that it is prepared to take responsibility for the bridge when it has been repaired. The Shire is not prepared to take responsibility for the maintenance debt or the PTA neglect.

The Shire understands that the Hon. Martin Aldridge MLC is asking a question on notice in the Legislative Council and believes a response will be due mid-September 2018.

The strength of the program provides a common language and framework to promote positive behaviour and relationships.

The program focusses on cultural change driving a positive behavioural change.

The Choose Respect program is at its most successful when it has wide community support. At the August 2018 Ordinary Council Meeting, Council agreed to participate as a Partner in the 'Choose Respect' program and Council is currently supported by the Toodyay Community Safety & Crime Prevention Association Inc., the Toodyay District High School and the Toodyay Police.

It is anticipated that a major launch will take place at the Toodyay Agricultural Show to be held on Saturday 6 October 2018 - more information on the launch will be posted on the Shire's Facebook page in the near future.

**President's Pen - Cr Brian Rayner** At the Ordinary Council meeting (OCM) held on 28 August 2018, Council resolved to increase rates by a modest 2.2% across the board for all categories of rate payers in the Shire of Toodyay. This increase in rates will assist Toodyay in embarking on four major infrastructure projects this year:

- ◇ Stage One of the Recreation Precinct;
- ◇ Re-roofing and repairs to Newcastle Gaol Museum;
- ◇ A new Fire Station for the Coodle-Nunile Volunteer Bush Fire Brigade; and
- ◇ Extensions to the Morangup Fire Station which houses the State Emergency Service vehicles.

The Shire of Toodyay will be holding a public meeting on Saturday 20 October 2018 to update the Community on the progress of Stage One of the Recreation Precinct. We would love to see as many community members as possible there to hear how this wonderful project is coming along.

The Shire is working with the Toodyay RSL Sub Branch on renovations to the old gardeners' shed on the corner of Fiennes and Clinton Streets. The RSLs intentions are to establish a Museum and Memorabilia Centre which will support and enhance the Central Heritage Precinct.

Council also passed a resolution at the OCM in August 2018 to partner with the Toodyay Community Safety and Crime Prevention Association, Toodyay District High School, and Toodyay Police in launching the Choose Respect Program. This program will be launched on social media and the Shire Website prior to the official launch at the Toodyay Agricultural Show on Saturday, 6 October 2018. We invite all organisations, businesses, sporting groups and community members to become involved in the 'Choose Respect' campaign for the benefit of all.

## We have the Federal Grant – What Now?

By now everyone has heard that Toodyay has received a **\$4.7 Million grant** under the Building Better Regions Fund. What does it all mean and what will we get for the money.

The grant is for a specific purpose and can only be used for the purpose set out in the grant program. The total cost of the project is estimated at \$11.8 million. The Shire will be applying for other grants to help fund the balance, but the project will proceed regardless.

What we applied for, and what we will build is:

- ◆ **A new aquatic facility.** This is a 6 lane 25 metre seasonal swimming pool, with a separate learn to swim pool and a splash pad for water play. There will of course be all things that go along with that including pumping and filtering, change rooms, kiosk, first aid room, fencing and landscaping;
- ◆ **A rectangular playing field.** The field will accommodate soccer, hockey and the two rugby codes. The surface will be good old fashioned grass.
- ◆ **Multi-use Courts.** The courts will be marked for Tennis, Basketball and Netball. The configuration will likely be 2 Tennis, 2 Netball / Basketball, and 2 courts marked for all 3

sports. That means each of the three sports will be able to be played on 4 of the 6 courts.

◆ **Change rooms** sufficient for the needs of all the sports. There will also be a dedicated storage space for each of the sporting groups.

◆ **Sports pavilion** suitable for after match functions and other social activities.

◆ The project also includes all **reticulation, landscaping, pathways** and a children's **playground**.

◆ **Lighting** for all sports will also be included, as will **parking areas**.

This stage of the project does not include a new oval or multipurpose function centre. The existing oval at the showgrounds will continue to host cricket and AFL football. The existing sports pavilion will be spruced up, but this is not part of the funded project. We have commenced project planning and procurement. Construction is likely to commence in April 2019.

The grant funding can only be used for the project applied for and cannot be applied to other projects such as the railway footbridge.

We are holding a community BBQ on Saturday, 20 October 2018 so everyone can see the plans and talk to our staff. See the invitation in this Newsletter and send in your RSVP.

## Upgrade of Police Stables car park and Convict Links!

Over the past month work has been undertaken around the old Police Stables (opposite the Newcastle Gaol) to make the area safer and more comfortable for our museum visitors. Many thanks to our Works and Services Department for co-ordinating this work utilizing both Shire staff and contractors to complete the project.

Initially the Police Stables sign was moved a little bit further down the hill to allow the footpath in this area to be realigned closer to the edge of the road. This gives us more space in the car park where car bays will be marked out in the future. The bays will be positioned



so that cars are parked parallel to the road, enabling the maximum use of this space.

Extra drainage between the Stables and Shearing Shed has been installed to allow more efficient runoff of water in this area, and nearby trees were trimmed.

A two metre brick pathway has been laid all around the Stables as well as joining on to the Wicklow Shearing Shed. This makes the whole area much safer for pedestrians moving between the two buildings which are, of course, at a different height.

Extra dirt has been brought in, evened out and compressed over the entire Stables car park area. Final surfacing is now waiting for the ground to dry out sufficiently before this is undertaken.

The September 2018 newsletter of the Western Australian Genealogical Society's Convict Interest Group, *Convict Links*, features a report of a July 2018 visit by members to the Toodyay Convict Depot exhibition at the Newcastle Gaol Museum. The large group visiting also included descendants of Enrolled Pensioner Guards and Sappers and Miners with connections to Toodyay. The report is extremely complimentary of the research work being undertaken in this area through collaboration with the Shire and the Toodyay Historical Society.

**Rainbow Lorikeet - A Pretty Powerful Pest!**

The Rainbow Lorikeet, although a beautiful bird, is also a destructive one. The Department of Primary Industries and Regional Development has declared the Rainbow Lorikeet to be a pest species south of the 20th parallel and a number of these birds have been seen within the Shire. They were reported to the Department and 33 birds have been effectively removed.

Holders Fire Response Vehicle Identifier Stickers are advised that issued stickers will expire on the 30 September 2018. The Shire has recently provided existing sticker holders with instructions on confirming details and requesting updated stickers.

The stickers aim to assist authorities identify vehicles which can support DFES or the Local Government in bushfire response. The Shire encourages existing holders to seek updated stickers or owners of such vehicles or machinery who have not previously applied to lodge an application for a Fire Response Vehicle Identifier windscreen sticker.

**New Online Fire Permit Application Process**

By the time the next Shire Newsletter hits the street and inboxes the Shire will have entered the Restricted Burning Period. Subject to seasons variation, permits will be required during the months of October. To assist with lodgement of requests and processing by the Shire Bush Fire Control Officers the Shire will migrate from the email application process to the use of an online form on the Shire's website. Prior to the commencement of the Restricted Burning Period this form will be made available on the Fire Restrictions and Permits page of the Shire's website (<http://www.toodyay.wa.gov.au/Resident-Services/Fire-Awareness/Fire-restrictions-and-permits>). The revised process will also make applying for reissue of permits more streamlined with the ability to request a new permit based on a previous permit (issued after 1 October 2018). While the Shire encourages the direct use of the online form, applications may be made via phone 9574 9300 during Administration Centre office hours.

**FIREBREAKS**

Firebreak Season is fast approaching and now is the time to start thinking about preparation. Rangers will be conducting inspections as of 1 November 2018 as per the Firebreak Notice that each property receives annually with their rates notice. The Firebreak Notice can also be accessed via the Shire of Toodyay Website at: <http://www.toodyay.wa.gov.au/Resident-Services/Fire-Information/Fire-Break-Notice>

Currently as of 1 October 2018 the Restricted Burning Period will begin and a permit will be required for **ANY** burning off after that date. Please ensure that if you are unable to undertake the works required to meet Firebreak standards, you seek assistance or engage with suitable contractors.
