In relation to a zone, a use identified in the zoning table for this Scheme (regardless of the symbol used) as a use that is not permitted in the zone unless the local government has exercised its discretion by granting development approval after advertising the application in accordance with clause 64

'D' Use

in relation to a zone means a use identified in the zoning table for this Scheme (regardless of the symbol used) as a use that is not permitted in the zone unless the local government has exercised its discretion by granting development approval; but does not include a class A use.

'P' Use

In relation to a zone, a use identified in the zoning table for this Scheme (regardless of the symbol used) as a use that is permitted in the zone if it complies with any relevant development standards and requirements of this Scheme

'X' Use

In relation to a zone, a use identified in the zoning table for this Scheme (regardless of the symbol used) as a use that is not permitted in the zone

A Recognised Emergency Management Body

A body that has a role or function under a plan that is for coping with emergencies / natural disasters (prepared by the Commonwealth or a state or territory);

Acid Sulphate Soils (Ass)

Any naturally occurring soils or sediment containing iron sulphides

Acquittal

A report outlining how the funding provided was spent, details of activities undertaken and the outcomes of the funded activity. The complexity of the report is proportionate to the funding level.

Act

This will depend on what will be relevant to a particular policy, directive, framework, strategy or other corporate document.




Adjoining Land

Land abutting site or is separated from it only by a road, pathway, driveway or similar thoroughfare.

Adjoining Properties

Any land (or owner of land) which abuts an application site or is separated from the site only by a pathway, driveway, right-of-way or similar thoroughfare. Examples below:

Administration

The Local Government's management, administration and operation staff.

- (b) airborne device anchored to any land or building used for the display of advertising; and
- (c) any vehicle or trailer or other similar object placed or located so as to serve the purpose of displaying advertising.

Advocacy

Refers to Council advocating on its own behalf or on behalf of the community with another level of government or another body or agency. In the context of this policy it is advocating for the best interests of the Shire and the community by influencing other bodies or agencies which could include the EPA, Department of Minerals and Petroleum or a mining proponent.

Affected Person

A person who owns (or occupies) land:

- (a) that adjoins an application site; or
- (b) the enjoyment of which may be detrimentally affected by the use of, or development on an application site.

Affiliated Person

Any person who is a member of -

- (a) The Pigeon Racing Federation of Western Australia;

Agriculture

The science or practice of farming, including cultivation of the soil for the growing of crops and the rearing of animals to provide food, wool, and other products. This includes cropping, animal husbandry including

Alfresco Dining

Outdoor dining or drinking or both in a public place.

Alfresco Dining Area

An approved area in which tables, chairs and other structures can be placed for the supply and consumption of food or beverages, or both.

Furniture and other approved items must be always located within this area when the business is operating.

Alfresco Dining Permit

A permit, approved by the Shire of Toodyay, which allows the operation of an Alfresco dining area in a public place

Under the Thoroughfares and trading in thoroughfares and public place local law 2001, a permit from the Shire of Toodyay is required to operate an alfresco dining area in any public

Amenity

All those factors which combine to form the character of an area and the comfort and convenience of its use. It also includes the present and likely future amenity.

Outdoor Workers

Workers that perform the majority of their working hours outdoors and undertake work that requires the use of work wear and PPE.

Owner

Procedural Justice

Procedural Motion

Procedure

A document containing prescriptive detail about specific action-oriented processes (i.e. the way to carry out an activity or a process), necessary to achieve strategic or policy objectives – for internal use.

Some examples include standalone sculptures, wall etchings, and painted walls that are read, or interpreted as art. This will not include simply coloured walls.

Public Auction

Real Property

Recordkeeping System (SRO Glossary)

 - (ii) conferences or conventions; and
- (b) where the period of occupancy of any lodger is not more than 14 consecutive days, and includes youth camps, youth education camps, church camps and riding schools.

Recurrent Breach
