

## Shire of Toodyay Local Planning Strategy 2017

The Shire of Toodyay Local Planning Strategy was endorsed by the Western Australian Planning Commission on 22 June 2018.

The Strategy has been prepared in accordance with the Shire's statutory requirements under the *Planning and Development Act 2005* and the *Planning and Development (Local Planning Schemes) Regulations 2015*.

The purpose of the Strategy is to enable Council and the community to determine the vision and strategic planning direction for the Shire of Toodyay for the next 10 to 15 years.

Preparation of the Local Planning Strategy has included assessment of all relevant State, regional and Council plans, policies and strategies. Community input into the Strategy has been achieved through surveys on key planning issues.

The Local Planning Strategy has been arranged into two main parts:

*Part One – Local Planning Strategy*, which comprises:

- The vision and objectives of the Local Planning Strategy

- Strategies and actions which will deliver the desired outcomes for the major planning theme areas

- Implementation and review.

*Part Two – Background information and analysis*, which comprises:

- An introduction that provides the background to the development of the Local Planning Strategy
- The State and regional planning context
- The local planning context
- Local Profile and key issues, which have been identified through an analysis of the local environment and the major influences on planning for the future.

The endorsement of the Strategy now enables the new Local Planning Scheme No. 5 to be drafted, which will be publicly advertised for comment in the near future.

The main objective of this EOI is to obtain the best outcome in relation to retaining, conserving and improving the historical character and heritage of this property.

This property contains a heritage listed Victorian Georgian cottage c1859 and outbuildings on a generously sized 1.0042ha rural residential zoned lot in the Bejoording area of the Shire of Toodyay. It has an attractive outlook in an area that has a number of developed Rural Residential lots and farmland around it. It is located 24km from Toodyay in the Avon Valley and 111km Northeast of Perth, Western Australia.

In addition to the dwelling and outbuildings, there are opportunities for further development on the land. It should however, be noted that while this lot can be serviced by power there is no reticulated water/sewer supply available to the site due to its location. **Proposed Cat Local Law 2018** The Shire of Toodyay proposes to make a local law relating to cats.

The **purpose** of this local law is to provide Council with measures in addition to those under the *Cat Act 2011* to control the keeping of cats.

The **effect** of this local law is to control the number of cats that can be kept and the places where cats can be kept.

The **justification** for the local law is that it will provide enforcement options for issues that previously are unable to be dealt with by the

Shire's authorised officers under the *Cat Act 2011* or its subsidiary legislation.

## MASSIVE SPORTING WIN FOR TOODYAY

**Toodyay Sport and Recreation Precinct in Toodyay will be funded under the Building Better Regions Fund - Infrastructure Projects Stream.**

**The Coalition Government is investing \$4,710,000 in Toodyay**

**Building Better Regions Fund making important dreams become reality of local communities.**

Toodyay is set to benefit following the announcement that the Toodyay Sport and Recreation Precinct project will be funded under the *Building Better Regions Fund – Infrastructure Projects* stream. Federal Member for Pearce, Christian Porter, said the Toodyay Sport and Recreation Precinct can now become a reality after receiving over \$4.7 million through the Coalition's Building Better Regions Fund.

"This is a fantastic outcome for the Toodyay community, with the project receiving funding to develop a sport and recreation precinct that will include sporting fields, change rooms and a much wanted aquatic center," Mr Porter said.

"Toodyay has never had a public swimming pool and the community has clearly identified its desire for a pool and improved sporting facilities as high priorities.

"This will have major flow on benefits across the Toodyay community, including economic, social and job creation, ensuring the region continues to thrive and prosper into the future.

"The Toodyay Sport and Recreation Precinct will provide a place where locals can stay active, remain socially connected and will generally improve and enhance the Toodyay community.

Minister for Regional Development, Territories and Local Government John McVeigh said the project will deliver significant economic and social benefits to the community.

"Under round two of the *Building Better Regions Fund – Infrastructure Projects* stream, the Coalition Government is investing well over \$200 million in 136 projects with a total leveraged project value of \$459 million," Dr McVeigh said.

"This means, in each successful community much anticipated local projects are receiving the funds needed to take a big idea and make it a reality.

Shire of Toodyay Acting Shire President Cr Therese Chitty said, "This project is the culmination of many years of hard work and commitment by successive Councils and many Shire staff, especially our CEO Stan Scott. It will be a game changer for Toodyay. I would like to thank all of those involved for their perseverance and Christian Porter and his staff for their support and encouragement over the journey."

A further \$200 million was announced in the 2018-19 Budget for a third round of the *Building Better Regions Fund* - a clear indication of the Coalition Government's commitment to create jobs, drive economic growth and build stronger regional communities into the future.

The second round of the *Building Better Regions Fund*, which includes the Community Investments stream and the Infrastructure Projects stream, is expected to create some 10,000 jobs from over 240 projects.

There were a few contentious items in the June 2018 CM agenda, firstly the Communication Policy. This was discussed again at the forum on 10 July 2018 where Councillors had suggested some changes that may make this more acceptable, this item is likely to come back to Council at the September 2018 OCM.

The second agenda item was the Public Question time policy this was defeated 7/0 (Cr Rayner on a leave of absence and Cr Greenway an apology).

Council resolved to enter into a five year Memorandum of Understanding with the organisers of the Make Smoking History Targa West Rally.

Council adopted the Museum Five Year Strategy, and well done to all those involved in the development of this strategy. This strategy is assisted by the announcement of a grant to help with re-roofing the old goal and a heritage walk trail. Congratulations to all staff involved in writing up this grant application.

Early August 2018 the WALGA conference and AGM is being held at the State Convention Centre, we have two delegates attending the AGM Crs Rayner and Greenway. Crs. Dow, Manning, Brook, Rayner and Greenway will also be participating in the convention program.

Currently Councillors and management have had two meetings regarding the budget for 2018/19 with another scheduled 19 July, Councillors

There has been discussion in local governments all over Australia regarding the use of social media for Elected Members. I have taken a few paragraphs from the WALGA guidelines that may help those in the community understand what is expected of our Elected members use of Social media.

*"As an Elected Member your private online identity may become blurred with your Local Government identity and any inappropriate public comment or content may damage the reputation of yourself, another person or your Local Government."*

*Consequently, the public perception may be that there is no distinction between statements made in an official capacity on behalf of your Local Government and those made as an individual Elected Member. If the comments made privately were inappropriate and they become public, you will be accountable under your Code of Conduct and the Local Government (Rules of Conduct) Regulations 2007.*

*"Does it criticise the work of your Local Government?"*

*Publicly criticising the work, the administration, the Council, Elected Members, Employees or Contractors of your Local Government is almost always going to be seen as a breach of the Rules of Conduct. As an Elected Member, people will assume that you have a high level of knowledge about what your Local Government does, and that you may have access to sensitive information. They will think that you know 'what's really going on'. Your comments have a strong capacity to affect your Local Government's reputation.*

*If you have serious concerns about the way in which your Local Government is being run or the behaviour of another Elected Member or an Employee, there are proper ways to report these. Posting on social media is not the*

*"What about my right to freedom of speech?"*

*The common law recognises an individual right to freedom of expression. For Elected Members, this right is subject to limitations imposed by the Rules of Conduct."*

**Reconciliation Week**

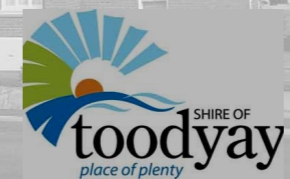
The Shire President, Deputy, President, staff and local Aboriginal people gathered for lunch during Reconciliation week recently.

**Disabled Bay Parking**

The Shire has a number of Disabled Parking Bays within the town centre which are patrolled for appropriate use.

The Rangers would like to remind the public to be mindful of these Disabled Bays and those that need to utilise them. For appropriate use, an

ACROD (Australian Councillor Rehabilitation of Disabled) sticker must be clearly displayed. Infringements will apply for actions in contrary to The Shire of Toodyay Parking and Parking Facilities Local Law, this includes failure to display an ACROD sticker.

**Museum News**

We have recently upgraded our Toodyay Convict Depot exhibition at the Newcastle Gaol Museum.

A new 55 inch screen has been installed and a 6 minute video is now playing for our visitors. Narrated by well-regarded journalist, presenter and producer David de Vos, the video tells the story of Western Australia's convict era and the part Toodyay played.

The establishment of a Convict Depot at Toodyay between 1851 and 1872 saw completely different groups of people arrive and join the Balladong people and European settlers who were already here. These included military personnel from the Corps of Royal Engineers, Pensioner Guards and transported convicts.

In 2014 the archaeological remains of the central section of the Depot were State heritage listed. These are buried beneath and around the Shire of Toodyay's administrative centre and include the foundations of the barracks, hospital, kitchen and warders' quarters.

The Convict Depot exhibition is located in the last surviving building that has a direct association with the Toodyay Convict Depot.



**SUCCESSFUL LOTTERYWEST GRANT—\$197,000**

The Shire's successful application for a LotteryWest grant of \$197,000 will help replace the existing timber sheoak shingle roof on the heritage listed Newcastle Gaol and carry out much needed repairs to other parts of the building. The grant also allows for interpretive works to be carried out.

The grant will assist the Shire to conserve this place of considerable cultural heritage and significance for the enjoyment of local and broader communities.

The re-shingling practice is an old building method and could be celebrated by the community with Shire run workshops and demonstrations. The grant funding will enable the preservation of a State Heritage listed building so that it can be appreciated by future generations.

**Works at our museum site**

At the end of June work commenced around the Newcastle Police Stables to improve drainage and provide more comfortable visitor access to this part of the museum precinct.

First a soak well was placed between the stables and the shearing shed and new underground stormwater drainage pipes were installed, connecting to the existing drainage system along the road. The Newcastle Gaol and Police Stables sign was moved 3 metres down the road to accommodate the surfacing of the car park in front of the stables. The car park will be smoothed out on an even slope down to the road from the stables. Car parking spaces will be marked with cars facing either side of the car park, parallel to the road. This will be the most efficient use of the available space.

A two metre wide brick pathway is being laid around the stables and leading up to the steps of the timber decking of the shearing shed. A small section of wooden fencing adjacent to the stables has been removed to allow easy access from the car park to this part of the museum precinct.

All of this work will enhance the safety and appearance of the site as well as ensuring water is drained more appropriately away from our historic buildings.

**HERITAGE GRANTS PROGRAM**



**About the Heritage Grants Program:** The Heritage Council's annual Heritage Grants Program offers assistance to private owners of State Registered heritage places to undertake urgent conservation works, or develop conservation management plans or strategies. Grants of up to \$100,000 are available through a competitive process and owners are required to match funds to the projects.

**Eligibility:** Only places included in the State's Register of Heritage Places and those that have been accepted for assessment are eligible. For places that have been accepted for assessment but are yet to be registered, the place must have been under assessment for five years or more. Places under assessment are currently restricted to applying for conservation management plans only. To check the status of your

property, visit [inHerit](http://inHerit) or contact us. When searching inHerit, ensure you check the *Limit my search to the State Register* box to avoid generating ineligible listings.

**Who can apply?:** All private owners and corporations can apply **except:**

- Property owners who have held the Title 3 years or less \*
- Commonwealth, State and local government agencies
- Heritage grant recipients who are yet to complete works funded in previous years.

Not-for-profit organisations that are eligible for [Lotterywest](http://Lotterywest) funding. \* Applications from new owners may be considered in special circumstances. \*\* A grant application may be considered where a not-for-profit organisation demonstrates a conscientious objection to funding from Lotterywest, or does not meet Lotterywest's funding criteria.

The Heritage Grants Program is open for applications until midday, **Wednesday 8 August 2018**.
